Maximum storage period is **Saturday, October 24, 2026 to Saturday, May 1, 2027**. All vehicles must be removed by Saturday, May 1, 2027 unless special arrangements are made in advance, in writing. A \$5.00 per day penalty will be incurred if stored items are not removed by Saturday, May 1, 2027.

All access to storage, including drop off and removal, should be by appointment with the 4-H Volunteer and/or 4-H Staff member overseeing 4-H Acres Educational Teaching Facility.

Renter will remove all gasoline and combustibles from stored vehicles.

Renter shall defend, indemnify, and hold harmless the CCE-Tompkins, its officers, directors, employees, volunteers, and agents from all claims, demands, liability or other proceedings for any actual or alleged injury to persons, including death, or damage to property arising out of the use of the premises by the Renter, its employees, guests, invitees, agents or subcontractors. The Renter agrees to indemnify and hold harmless CCE-Tompkins for any physical damage, losses relating to theft, or other losses of any nature whatsoever to the stored vehicle or personal property within the vehicle. The Renter shall keep the vehicle and any contents insured against fire or other damages, naming CCE-Tompkins as an additional insured, and shall provide a copy of proof of insurance to CCE-Tompkins.
2. Renter assumes all responsibility for loss or damage to vehicle. CCE-Tompkins, **its officers, directors, and employees** assume **NO** responsibility for **any loss of, damage to or destruction of the** vehicle while in storage or on the grounds **regardless of the cause**. Renter releases and waives any right of recovery **from** or subrogation against CCE-Tompkins, its officers, directors, and employees for any **loss of, damage to or destruction of any of the property of the Renter regardless of the cause of said loss or damage. This waiver and release shall be in effect regardless of whether the renter has insurance and shall be applicable to and binding on the insurance company or any loss payee or lien holder of the renter. If this provision is challenged by any third party the Renter shall defend CCE-Tompkins, its officers, directors, and employees against any such challenge and shall be responsible for any costs, including reasonable attorney's fees, damages or liability incurred by CCE-Tompkins.**
